On behalf of the St. Mary Education Committee, faculty and staff, I am pleased to present our 2017-2018 Annual Report to summarize the highlights of our previous year.





SPIRITUALLY







Our students' spiritual growth is central in all that we do at St. Mary. We believe this is what sets St. Mary apart. St. Mary students participated in a wide variety of activities this past year, including assisting in weekly Masses, Adoration, daily prayer, attending and leading annual retreats for all grade-levels, completing service projects throughout the community, participating in See You At The Pole and attending the National Catholic Youth Convention in Indianapolis, Indiana.

St. Mary High School students must have 75 hours of Christian service completed in order to graduate. *In 2017-18 our graduating seniors had an average of 147 hours each.* We are proud of their desire to serve far above what is required.

ACADEMICALLY

From our 5 Star Rated preschool to the highest composite ACT scores in our community, St. Mary School System strives to live out our mission to "empower students academically... and nurture learners to become a positive influence on others."

Academic Highlights



Abbigail Vannatter was accepted to participate in the **2018 Governor's Scholar Program (GSP).** (St. Mary consistently has students selected for GSP, GSA and GSE.)



St. Mary Middle School Students **won the** Murray State Stock Market Games.

Emily Hodges was selected as a **National Merit Finalist**. Nearly 1.6 million students in more than 22,000 high schools entered the 2018 National Merit Scholarship Program. Only 15,000 advanced to the Finalist level.

43% of St. Mary High School Students and 30% of St. Mary Middle School Students are eligible to be members of the National Honor Society and the Honors Assembly based on GPA, teacher recommendations, and service.

With a gift from an alumni donor, St. Mary High School began an Investment Club in 2018. Students are gaining first hand experience with investing and financial literacy. **St. Mary has the only school Investment Club offered in the region.**



Dual-Credit Program:

The St. Mary Dual-Credit Program allows high school students the opportunity to graduate with transferable college credit. Through our partnerships with Brescia University and WKCTC, our **2018 seniors graduated with an average 13 hours of college credit!**

In fact, 85% of our graduating class participated in the Dual-Credit program .



With 32 sports teams and 29 clubs/organizations, St. Mary students have the unique opportunity to be involved and grow as participants and leaders.

During the 2017-2018 school year, our student-athletes competed and won many times! However, we also believe that being a St. Mary athlete is more than just the score, it is how you compete. We are proud that for the second year in a row, the St. Mary Boys Basketball team won the Region 1 **Rex Alexander Sportsmanship award** which is voted on by the officials and awarded based on conduct on the court.

In addition, St. Mary High School was recognized by the Kentucky High School Athletic Association (KHSAA) as **one of only 49 schools across the state who had zero disqualified players or coaches during the 2017-18 academic year.**

Congratulations to our athletes and coaches on a great year and for striving to live out the St. Mary mission even in competition.









St. Mary Fundraising

St. Mary School System is committed to keeping the cost of a Catholic education affordable for families while still providing outstanding learning experiences for our students. In order to do this, St. Mary relies on many financial resources. St. Mary School System's income is made up primarily of tuition, parish subsidies, and third-source funding. Third-source funding opportunities include the Annual Fund, restricted donations, and significant fundraising events such as the Auction, Oktoberfest, Bingo, and Scrip.

Annual Fund

The 2017-18 "I Aspire" Annual Fund was a success thanks to the generosity of our parents, grandparents, alumni, staff and community members! We set a goal of \$120,000 and we raised \$121,670! We exceeded the 2016-17 Annual Fund by nearly \$9,000!

These funds go toward tuition assistance and to cover operational expenses that are not covered by tuition and parish subsidies.

Bingo

St. Mary Bingo has been an important source of income for the school since 1981. In 2017-18, \$45,000 was raised through bingo to help support St. Mary. We couldn't do this without the help of our parents and community volunteers who make this significant fundraiser possible!

St. Mary Auction

The St. Mary Auction, which occurs every other year, attracts over 600 people and it is the single largest fundraising event for the school system.

The 2017 Auction was once again a huge success raising nearly \$250,000 for St. Mary through live and silent auctions!

Countless volunteer hours go into making this such a fun and successful weekend!





SCRIP

Scrip fundraising is a no-selling program that allows St. Mary families to raise money for the school and for their tuition by using gift cards, or scrip, to pay for everyday purchases. Families order gift cards from St. Mary at face value and earn a rebate. The rebate is split between St. Mary and the student's tuition. It is a win-win for the school and our families!


