New Business – The Honors Policy had a first reading. Faculty had input that students should not be allowed to have a D or F in the policy, and they wanted a minimum GPA for every year. This solves an issue with National Honor Society, and would still allow for them to be both, but not just an honor

graduate. Students would still earn the cord to wear at graduation. The committee recommends that all students be entered into the program, not just for the incoming freshman. There are no anticipated negative moves due to the change. If all students are allowed it would open up an opportunity for current seniors to graduate with honors where otherwise they would not have. The high school will also find better ways of reporting to parents on the status of their child progress in the program. First reading passes, with all aye votes. This must be approved by October 16th in order to be able to make effective for this school year. We will try and get the second reading into the Board training, otherwise a special meeting will be called in two weeks.

Discussion around an Employee complaint regarding cancelling fall break occurred, and it was decided that we knew it was a tough unpopular decision to make, but we reached consensus to remove the week and the decision will remain.
